



SUN PROTECTION

QUALITY AREA 2: CHILDREN'S HEALTH AND SAFETY

Policy Statement

We are committed to providing an environment that ensures all children, educators and staff are protected from ultraviolet (UV) radiation for all outdoor activities. This includes:

- ◁ Ensuring all children, educators and staff are well protected from too much UV exposure by using a combination of sun protection measures whenever UV levels reach 3 and above.
- ◁ Ensuring the outdoor environment is sun safe and provides shade for children, educators and staff.
- ◁ Ensuring children are encouraged and supported to develop independent sun protection skills.
- ◁ Supporting duty of care and regulatory requirements.
- ◁ Supporting appropriate WHS strategies to minimise UV risk and associated harms for educators, staff and visitors.

Background

The Education and Care Services National Regulations require policies and procedures to be in place in relation to sun protection. The sun's UV can't be seen or felt. Whatever the weather, it's important for people of all skin types to use sun protection whenever UV levels are three or higher. Too much of the sun's UV can cause sunburn, skin and eye damage and skin cancer. Australia has one of the highest rates of skin cancer in the world, with two in three Australians developing some form of skin cancer before age 70. Infants and toddlers up to four years of age are particularly vulnerable to UV damage due to lower levels of melanin and a thinner stratum corneum (the outermost layer of skin). UV damage accumulated during childhood and adolescence is strongly associated with an increased risk of skin cancer later in life. By teaching sensible sun protection habits from an early age and implementing sun protection measures, early childhood services can play a significant role in reducing skin cancer risk

Strategies / How will it be done?

Outdoor Activity

UV levels and daily sun protection times are used to plan daily activities and ensure a correct understanding of local sun protection requirements. A combination of sun protection measures will be used **whenever UV Index levels reach 3 and above**. These measures include:

- ◁ **Slip** on clothing that covers as much skin as possible
- ◁ **Slop** on sunscreen (except June / July)
- ◁ **Slap** on a hat
- ◁ **Seek** shade

◁ **Slide** on sunglasses that meet the Australian Standard 1067 (Sunglasses: Category 2, 3 or 4) and cover as much of the eye area as possible (if practical)

When children are on excursions all sun protection practices are planned, organised, understood and available.

Please Note: Children will not be allowed outside if the temperature is 38 ° C.

Shade

◁ All programmed outdoor activities will be planned to occur in shaded areas during October to March.

◁ Children are encouraged to choose and use available areas of shade when outside.

◁ Children who do not have appropriate hats or outdoor clothing are asked to choose a shady play space or a suitable area protected from the sun.

◁ The program will be set up in the shade and moved throughout the day to take advantage of shade patterns.

◁ The service will provide and maintain adequate shade for outdoor play.

◁ Shade options can include a combination of portable, natural and built shade.

◁ Regular shade assessments will be conducted to monitor existing shade structures and quality of shade

Hats

◁ Educators, staff and children are required to wear SunSmart hats that protect their face, neck and ears. A SunSmart hat is:

» Legionnaire hat.

» Bucket hat with a deep crown and brim size of at least 5cm (adults 6cm).

» Broad brimmed hat with a brim size of at least 6cm (adults 7.5cm).

Please note: *Baseball caps or visors do not provide enough sun protection and are not suitable.*

◁ Children without a SunSmart hat will be asked to play in an area protected from the sun (e.g. under shade, veranda or indoors) or will be provided with a spare hat (these will be washed at the end of the day).

Clothing

◁ When outdoors, educators, staff and children will wear SunSmart clothing that covers as much of the skin (especially the shoulders, back and stomach) as possible. This includes wearing:

» Loose fitting shirts and dresses with sleeves and collars or covered neckline.

» Longer style skirts, shorts and trousers

◁ Children who are not wearing SunSmart clothing are encouraged to play in an area protected from the sun (e.g. under shade, veranda or indoors).

Please note: Midriff, crop or singlet tops do not provide enough sun protection and therefore are not recommended.

Sunscreen

◁ All staff and children will apply SPF30+ broad-spectrum water resistant sunscreen 20 minutes before going outdoors and re-apply every 2 hours.

◁ Where appropriate, children are encouraged and supported to apply their own sunscreen under the supervision of staff.

◁ Permission to apply sunscreen is included in the service enrolment form. Where children have allergies or sensitivity to the sunscreen, parents are asked to provide an alternative sunscreen, or the child will be encouraged to play in the shade.

◁ The centre will supply SPF 30+ broad spectrum water resistant sunscreen. All sunscreens will be stored in a cool, dry place and the expiry dates monitored.

Babies

◁ Babies under 12 months will not be exposed to direct sunlight.

◁ Babies clothing, hat and shade positioning are checked regularly to ensure they continue to be well protected from UV.

◁ The use of sunscreen on babies under 6 months is not recommended due to their sensitive skin.

Education

Sun protection is incorporated regularly into learning programs and role-modelled by educators.

◁ SunSmart App daily UV times are promoted to guide staff, parents and children's behaviour.

◁ June/July UV is mostly below UV Index 3 hence sunscreen is not compulsory – however hats or beanies must be worn in June/July when outside.

◁ Educators are encouraged to complete Cancer Council's free Generation SunSmart online learning modules.

◁ Children are encouraged to be involved in initiatives to promote and model sun protection measures at the service including taking leadership roles in managing sun protection e.g. accessing daily UV levels and sun protection times, hat reminders and management of sunscreen.

◁ Visitor, student and new employee inductions embed the transfer of information relating to the service's Sun Protection Policy.

Information and policy availability

◁ *Sun protection* policy, procedures, requirements and updates are made available to staff, families and visitors.

◁ Sun protection information and resources are accessible and communicated regularly to families.

◁ All parents/families are informed of the sun protection policy including appropriate hat, clothing and sunscreen requirements on enrolling their child in the service

WH&S

As part of WH&S UV risk controls and role-modelling, educators, staff and visitors:

◁ wear a suitable sun-protective hat, covering clothing and, if practical, sunglasses

◁ apply sunscreen and

◁ seek shade whenever possible. Sun protection considerations and actions are included in risk assessments for excursions and excursion checklists

Review

- ◁ Management and staff regularly monitor and review how effectively they implement their sun protection policy.
- ◁ Maintain recognition as a SunSmart Service.

Early Childhood Educators	<ul style="list-style-type: none">◁ Adhere to the strategies and practices of the Sun Protection Policy.◁ Educators and staff will act as role models and demonstrate SunSmart behaviour by:<ul style="list-style-type: none">» Wearing a SunSmart hat (see Hats).» Wearing protective clothing, and sunglasses (optional) (see Clothing).» Applying SPF30+ broad-spectrum water-resistant sunscreen 20 minutes before going outdoors and every 2 hours after (see Sunscreen).» Using and promoting the use of shade.◁ Encouraging families and visitors to role model positive sun safe behaviours when at the service.◁ Check the UV Alert on a daily basis at www.sunsmart.com.au or using the SunSmart App or OWNA◁ Discussing sun protection with children and demonstrating a positive and proactive approach to the management of sun protection in the service.
Families	<ul style="list-style-type: none">◁ Dressing their child in cool clothing that covers as much skin as possible e.g. tops that cover the shoulders, arms and chest, collared shirts, longer style shorts.◁ Providing a sun protective hat that shades the face, neck and ears (e.g. wide brimmed, bucket or legionnaire style).◁ Provide permission for educators/staff to apply SPF 30 or higher broad spectrum, water resistant sunscreen supplied by the service to all

exposed parts of my child's skin including their face, neck, ears and **arms** OR

< Provide permission for educators/staff to apply SPF 30 or higher broad spectrum sunscreen (that I have supplied and labelled with my child/ children's name) to all exposed parts of my child's skin including their face, neck, ears and arms. I agree that this sunscreen will be kept at the service and it is my responsibility to make sure there is always an adequate supply available.

< Practicing SunSmart behaviours themselves when at the service.

Monitoring, Evaluation and Review

This policy will be monitored to ensure compliance with legislative requirements and unless deemed necessary through the identification of practice gaps, the service will review this Policy every two years.

Families and staff are essential stakeholders in the policy review process and will be given opportunity and encouragement to be actively involved.

In accordance with R. 172 of the Education and Care Services National Regulations, the service will ensure that families of children enrolled at the service are notified at least 14 days before making any change to a policy or procedure that may have significant impact on the provision of education and care to any child enrolled at the service; a family's ability to utilise the service; the fees charged or the way in which fees are collected.
